The training will be conducted in **English** to facilitate the learning of a universal language for the furtherance of fellowship and coordination in the one new man.

Advisory

1. **General:** All training meetings will be held at the Bible Truth Ministry(BTM), Yong-in City, Korea. You can visit the official website at: <http://icta-2026.com>
2. **Training:** The training will cover the same subject as the July Semiannual Training and will be conducted in English.
3. **Schedule:** Training Meetings will be from July 21 to 24, 2026, followed by a blending trip from July 24 to 26, 2026. All trainees should arrive a day before the start of the training, on July 20. The recommended departure date is July 26, 2026, preferably after 6 PM.
4. **Lodging:** Hospitality will be provided from July 20 through July 25, and meals will be provided from dinner on July 20 to dinner on July 26.
5. **Transportation:** Airport pickup service will ONLY be available on July 20 at Incheon International Airport (ICN). Please book your flight and make arrangements accordingly.
6. **Registration:** All training participants should complete their registration **by April 30, 2026**, according to the following guidelines:

- a. All participants should be registered corporately by region or country (a quota has been assigned to each region or country due to the limited capacity of BTM).

The quota for each region or country is as follows:

Taiwan: 300	The Philippines: 100
Malaysia: 60	Indonesia: 50
Hong Kong: 50	Singapore: 25
Thailand: 15	LMA Countries: 25 (India: 15)
Korea: 180	

- b. All participants must attend both the training meetings and the blending trip. Incomplete applications will not be accepted.
 - c. Individual registration is not accepted. Please use the official registration sheet to compile participants by region or locality, and submit it along with the registration fee to the designated ICTA contact person in your country. Download the official Excel form directly via the link below:

 - d. Each country's responsible person will receive access to the designated Google Sheet from the Korea Host Team. After receiving access, please enter the participants in that sheet in order.
 - e. Each registrant from overseas is required to submit a non-refundable fee of **\$380(USD)** to cover the cost of hospitality during the training and expenses for the blending trip. The payment guide is provided in the latter part of this document. Please make sure to follow the instructions when remitting the payment.
7. The attendance will be divided into two groups for church visitation and sightseeing.
 - a. The groups are as follows:
 - Group A: Northern Part of South Korea
 - Group B: Southern Part of South Korea

- b. Please note that participants assigned to Group A are recommended to depart for their home countries from Incheon International Airport (ICN) on July 26 after 6:00 PM. Participants assigned to Group B are recommended to depart from Busan International Airport (PUS) on July 26 after 6:00 PM.
- c. For the blending trip, registrants are encouraged to coordinate with others from their region and select the same option (A or B) when registering, so that they may be grouped together in order to facilitate grouping. Assignments will be made on a first-come, first-served basis.
- d. Make sure that you purchase the flight tickets after receiving the confirmation from the Korea Host Team about which group you are assigned to.

ICTA 2026 OFFICIAL PAYMENT GUIDE

Primary Method: Wise (Adopted to minimize fees & ensure fast processing).

SECTION A. For Countries with **Wise Access** (*Philippines, Malaysia, Indonesia, Hong Kong, Singapore*) *Recommended: **Wise App** (Low fees & Fast processing)

1. **Sign Up Only:** Download the Wise App and sign up (*Note: You MUST create a "Personal Account", not Business*).
2. **Initiate Transfer** (Follow this exact flow):
 - **Set Currency & Country:** Click "**Send**". Set **Recipient's currency** to **USD** and select Country: **South Korea**.
 - **Set Amount:** Enter exactly **380** (× Saints) in the **USD field** so that the app automatically calculates the amount. Then, ensure "You Send" is set to your **Local Currency** (MYR, SGD, IDR, PHP, HKD).
 - **Select Payment Method:** Tap "**Change**" (next to "Paying with") and strictly choose **the Low-cost transfer / Bank Transfer option (NEVER choose Debit/Credit Cards/SWIFT)**.
**PH: PESONet (one transaction for large groups) *MY: FPX (max 20-30 saints/transfer)*
**SG: PayNow or Bank Transfer *ID/HK: Bank/Manual Transfer*
 - **Add Recipient:** Tap "**Add recipient**" → Select "**Find on Wise**".
 ✓ Search ID: **@begq41** → **Verify Name:** "진주시 교회" (The Church in Jinju).
3. **Verify your Identity:** Follow the prompts to verify ID (Select "ID Issuing Country" correctly).
4. **Critical Questions** (Compliance):
 - "What's your account for?": Select **Sending money to friends or family**.
 - "What's the reason for your transfer?": Select **Travel expenses**
 (🚫 **WARNING: DO NOT select "Pay for goods and services" to avoid blocking**).
5. ⚠️ **Payment Reference** (Review Page):
 - On the "**Review details**" screen, scroll to the **BOTTOM** to find the "**Reference (optional)**" box. You **MUST** enter as: **ICTA26 Travel [Country] No [X]**
*[X] = Transfer No. NEVER use "Group", "Fee", or "Pay". (Ex: **ICTA26 Travel Malaysia No 1**).*
6. ⚠️ **Post-Transfer Security Check** (If prompted): Upon completion, if Wise asks for more details about your reference (e.g., "ICTA26"), answer exactly as follows:

- **"What does the reference refer to?":** If you see options like *A person's name / A business or organisation / A vessel*, you **MUST** select **None of the above**.
- **"Reason for the transfer?":** Copy & paste exactly:

SECTION B. SWIFT / Bank Wire Only (*Taiwan, Thailand, LMA countries such as India*)

*Required: **International Bank Wire (SWIFT)** via Local Bank

1. **Strategic Grouping:** Minimize fixed bank fees (approx. **\$35-\$50** per transaction) by **grouping efficiently**.
 - **Taiwan:** Online Banking limit is approx. **USD 15k (40 saints)**. For larger groups (e.g., 300 saints), visit **Bank Counter** to send at once.
 - **Thailand, India, Others:** Combine into **one large transfer** (Maximize size).
2. **Currency Rule:** You **MUST** select **USD** as the sending currency. ⚠️ *Do not send in local currency.*
3. **Fee Option:** When asked "Who pays fees?", select **"OUR"** (Sender pays all). Church must receive the exact net amount.
4. ⚠️ **Purpose & Reference** (Remittance Info / Message to Beneficiary / Remark):
 - **Purpose:** Select **Travel Expenses** (or **Education**). *Do NOT select "Trade" or "Goods"*.
 - **Reference:** You **MUST** enter the code exactly as shown in **Section A, Step 5**.
